- Number of shares includes 246,375 performance shares (restricted stock units) previously reported that in the future will be converted on a one-for-one basis into shares of Applied Materials, Inc. common stock upon vesting, which vesting is scheduled to occur as follows: (a) 2,000 performance shares are scheduled to vest on 8/31/09; (b) 100,000 performance shares are scheduled to vest in two equal annual installments beginning 12/19/09; (c) 91,875 performance shares are scheduled to vest in three equal annual installments beginning 12/19/09; and (d) provided specified performance goals are achieved, 52,500 performance shares are scheduled to vest (i) as to 26,250 shares no earlier than on 12/19/09 and (ii) as to 26,250 shares no earlier than in two equal annual installments beginning 12/19/10 (all vesting is subject to continued employment).
