Represents number of shares that were automatically withheld upon vesting of performance shares (restricted stock units) to cover tax withholding obligations in a transaction exempt under Rule 16b-3. Number of shares has been decreased to reflect the fact that 15,725 shares (not 15,947 shares) should have been reported as withheld on Mr. Flanagan's Form 4 filed December 21, 2011.

2. Number of shares has been increased from the number of shares reported in Mr. Flanagan's Form 4 filed December 21, 2011 to reflect the corrected number of shares withheld upon vesting of performance shares (restricted stock units). Number of shares includes 462,500 performance shares previously reported that in the future will be converted on a one-for-one basis into shares of Applied Materials, Inc. common stock upon vesting, which vesting is scheduled to occur as follows: (a) 131,250 shares are scheduled to vest in installments during each March of 2012 through 2014; (b) 131,250 shares are scheduled to vest in installments during each December of 2012 through 2014; and (c) provided specified performance goals are achieved, 200,000 shares will be scheduled to vest in installments during each December of 2012 through 2014; and the actual number of shares that may vest ranges from 0% to 150% of the target amount, depending on achievement of specified performance goals (subject to continued employment through each vest date).
